ORDER

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution Maharaja Agrasen College of Education, Badal Road, Jai Singh Wala, Bhatinda, Punjab was recognized by NRC vide its Order No. NRC/NCTE/ F-7/PB-343 dated 13.08.2006 for B.Ed. course for 100 seats.
- AND WHEREAS, the institution Maharaja Agrasen College of Education, Badal Road, Jai Singh Wala, Bhatinda, Punjab has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (i) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The application-Institution for additional unit will be required to submit the required documents such as (ii) land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents it available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - The Regional Committees shall arrange for verification of documents, inspection of these premises and (iii) check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the (iv) NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Maharaja Agrasen College of Education, Badal Road, Jai Singh Wala, Bhatinda, Punjab for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

Sub: Grant of temporary affiliation to Maharaja Aggarsain College of Education. Jai Singh Wala, Bathinda, for B.Ed. Course w.e.f. Academic Session 2006-07.

Sir.

With reference to your letter No. MAT/30/Pbi/06 dated 18.08.2006, it is hereby informed that subject to the approval of the Academic Council and fulfilment of the following conditions, the Vice-Chancellor has granted temporary affiliation to your new College named Maharaja Aggarsain College of Education, Jai Singh Wala, Bathinda, with an intake of 100 students to impart instructions in B.Ed. Course w.e.f. the academic session 2006-07:

- 1. An Endowment Fund amounting to Rs. 10 lacs is to be deposited with the University, within one month from the date of issuance of this letter, in the form of F.D.R. in the name of Dean, College Development Council, Punjabi University, Patiala.
- 2. An affiliation fee amounting to Rs. 50,009/- is to be deposited with the University in the form of Demand Draft in the name of Registrar, Punjabi University, Patiala within 15 days from the date of issuance of this letter.
- 3. The College will have to deposit the affiliation continuation fees every year, as per University norms, latest by 31 August.
- 4. In case there is any revision in Endowment Fund/Affiliation Γee/Continuation Fee by the Syndicate, the College is bound to pay the difference.
- The College will charge tuition fee and other charges as approved by the University and will maintain proper register/record of the same. No other fees and funds shall be charged by the College.
- 6. The Principal, teaching staff and librarian will be recruited/appointed as per U.G.C./NCTE/Punjabi University, Patiala norms/qualifications through a properly constituted Selection Committee under the rules.
- 7. The College shall pay salary to the faculty in the UGC grades as adopted by the Punjabi University Patiala. An affidavit to this effect, signed by the President of the Foundation/Trust/Society, and duly attested by the Magistrate (First Class), will be submitted to the University. The college will maintain the proper record of the salary of the faculty and staff.
- 8. The College will send cases of the duly selected/appointed Principal/Faculty Librarian, for approval from University, within one month from the date of their appointments.
- 9. The college shall submit the list of faculty members and supporting staff at the beginning of each academic year, latest by 15 August, every year. Any transference of management and all changes in the teaching faculty/staff shall be reported to the university immediately.
- The College will not, without the prior permission of the Academic Council, suspend instruction in any subject or course of study for which it is authorized to impart instructions.

- The College shall have a regularly constituted Governing body consisting of not 11. more than twenty persons including, among others, two representatives of the University and will hold regular meetings of the Governing Body. The university representatives shall be appointed by the University.
- The college building will not be used for any other purpose. 12.
- College once affiliated to this University, will not seek affiliation to any other 13. University for any course(s)/subject(s).
- The college will submit each year the statement of Annual Accounts to the 14. University, duly audited by a chartered accountant, latest by 30 June, every year.
- The College will impart instructions as per University syllabus. 15.
- The College must have arrangement with good practicing high schools which 16. should have experienced staff and adequate equipment. The list of such schools, along with a certificate from the school head to this effect, be also supplied to the University.
- The College will make available playgrounds to the students duly furnished and 17. appropriate arrangements for extra-curricular activities.
- The College will ensure compliance of conditions of NCTE, Jaipur imposed vide 18. their letter No. F.NRC/NCTE/F-7/4836/4837/4838/4840 Dated 13.8.2006.
- The College will be bound to abide by the University/NCTE/Punjab Government 19. rules issued from time to time.
- The College shall appoint the remaining required number of lecturers and 20. librarian as per norms within a period of two months and inform this office.
- If the College contravenes any of the above conditions or any of the 21. provisions of the Punjabi University Calendar, Rules, Regulations and Orders made or issued thereunder, the University may withdraw affiliation under section 1.1 of Chapter VI, Punjabi University Calendar, Volume 1, 1997.
- That in the case of subject combination, no institute will be allowed more 22. than 40% seats out of the total approved intake of seats, for the subject Social Studies-Languages combination. The affiliating University will also ensure no college is affiliated for more than 50% of the seats in the above mentioned subject in any case. Panjab University, Chandigarh will also ensure the same while conducting counselling to fill up the seats in the respective colleges.

It may be noted that this temporary affiliation is valid only for one year (2006-07). Further extension will be granted only after satisfactory compliance of the conditions imposed by the University/NCTE/Punjab Government.

It is hereby clearly stated that the compliance of the above conditions be ensured within one month or as specified, from the date of issuance of the affiliation letter and a detailed report of the compliance of the above conditions be sent to this office. If necessary compliance of the conditions can be checked up again by the University at any time without any prior notice.

Building completion certificate will also have to be obtained from the competent authority as per norms and standards.
- iii) That the applicant Trust will also obtain clearance from the affiliating University.
- iv) That the management of the Trust will ensure that the conditions of basic requirements/norms and standards of the Punjab Government/Punjabi University, Patiala /N.C.T.E. are fully complied with.
- v) That no financial assistance / grant will be given by the Government to this institute.
- vi) That in case, if at any stage, any limit for fees is prescribed by the Government, the Institute will comply the same.
- vii) That this approval is provisional and the same can be withdrawn at any time without any prior notice.
- viii) For the subject combinations, the institute will offer the subjects as per directions if any, of the affiliating University / Punjab Government.
